ASC presented a Main-stage Season consisting of 259 performances of 15 plays over 51 weeks. In addition, we implemented an Education Program Portfolio consisting of 6 Student Performance Residencies, 5 Summer Youth Ensembles, 82 in-class Workshops for students K-12, and an 8 month post-baccalaureate Apprentice Company Training program. All told, our programming reached 54,832 individuals (32,193 adults/22,639 students) from 90 Georgia counties, every state in the Union, and 13 foreign countries. ASC also hosted 6 other performing entities in our facility.
